1.1 Designation and characterization of the study program

"Master's program in International Relations" (MIB)

The MIB is a four-semester Master's degree program with a focus on research, but at the same time also a professional field-oriented degree. Graduates are awarded the academic degree Master of Arts. MA.

The standard period of study is four semesters. The program begins in the winter semester.

Regular study structure:

The required area comprises 40 ECTS credits. Students must successfully complete two modules from the political science sub-discipline of International Relations (20 ECTS credits). The internship (15 ECTS credits) and one Master's module from the Studium.Pro program (5 ECTS credits) are also part of the required program.

The required elective area allows students to set their focus. Students have to contribute 50 ECTS credits from the required elective area. They can choose from the modules offered by Political Science, History and Sociology.

Students must complete 10 ECTS credits in the elective area. Here, they can freely choose modules from the entire range of Master's degree programs at the KU that are not subject to admission restrictions or modules from other German or international universities. In particular, the offers of the KU Language Center can be used in the interest of further education in foreign languages.

The Master's thesis is worth 20 ECTS credits.

In case of completion of the specialization "European Studies", there are changes to this standard study structure as well as to the distribution of ECTS credits (see p. 11)

Number of study places:

There is no restriction. However, applicants must complete an aptitude test.

Lecturers:

Since there is no professorship of Public Law at the Catholic University of Eichstätt-Ingolstadt, the module "International Law - Sources, Principles, Current Developments" is partially taught by external lecturers in the context of of a teaching assignment.

Target group/addressees:

The Master's program in International Relations is intended for academically educated individuals who have earned their first professional degree in one of the following fields: politics, society, history, economics, law, or languages. It explicitly addresses applicants from abroad.

2. Profile and goals

2.1 Degree program objectives

The Master's program in International Relations centers on an in-depth academic examination of international relations, issues about political order, sociology, and contemporary history.

The focus in the required area is on Political Science and on its sub-discipline of International Relations. Two modules in this area are required modules. In addition, there is the required internship, which must be directly related to international or cross-border topics of the study program, as well as Studium.Pro, in which students can choose from various interdisciplinary Master's modules.

In the elective area, students can continue their education in core aspects of Political Science and also focus on History and/or Sociology. The courses specifically address individual problem areas and issues of the corresponding subject from an international perspective and offer in-depth access to their problem-oriented analysis. Students acquire the ability to transfer independently as well as to critically analyze, reflect and interpret subject-specific content at a high scientific level. They are also trained to present the results correctly and convincingly in written and oral form.

Depending on the module, the following professional skills are taught:

- In-depth knowledge of Political Science in the sub-disciplines of International Relations, Political Systems Theory, and/or Political Theory and Philosophy with a focus on International Relations:
- Knowledge of international law concepts, norms and problems;
- Historical analysis skills (related to selected aspects of recent history and contemporary history); and
- Knowledge of sociological theories and methods and insight into the processes of social and cultural change.

Due to the program's research orientation, the students' skills for independent scientific work are expanded and deepened. In addition, students are prepared for further scientific qualification, e.g. in the context of a doctorate.

The heterogeneity of MIB students as well as the opportunity to specifically experience international perspectives in an internship and/or during a study semester abroad contribute to the development of students' intercultural skills.

Furthermore, the students' personal development is promoted by the freedom of choice integrated in the program, within the framework of KU's Studium. Pro offer, the required elective area (see above) and the elective area. Especially through Studium. Pro and in the elective area, students can get to know other subject areas and acquire key qualifications oriented towards practical and professional fields. This enables them to form study preferences and to give their Master's degree program its own profile that corresponds to their interests and is beneficial for their career goals.

Graduates of the program thus acquire comprehensive skills for acting in international contexts and are qualified to take over responsible positions with international organizations, constitutional bodies, administrative authorities, research institutions, media and non-governmental organizations after graduation.

2.2 International orientation

The MIB has a pronounced international orientation. This is not only the result of the topics covered, but is also structurally anchored in the program itself (required internship, possibility to complete a semester abroad, specialization "European Studies", MIB in English).

In addition to the presence of international students, its international orientation can also be seen in the explicit incentives for spending stays abroad. In addition to the possibility of a structured study abroad in the context of the specialization "European Studies", a stay abroad is explicitly recommended, especially for students from Germany, for an internship as well as for studies of at least one semester. This is supported by the regulation in the General Examination Regulations (APO) of the KU stipulating that students who have successfully studied at least one semester at a foreign university can apply for an increase of the standard period of study by one semester — an opportunity that more and more MIB students take advantage of. Students are deemed to have studied at a foreign university successfully if they have completed study achievements amounting to more than 15 ECTS credits that can be added to their studies here.

During the Master's degree program in International Relations, up to two semesters can be spent studying at a foreign university. As a rule, the third semester is intended for this purpose. The coursework completed during the semester abroad will be recognized if it is comparable to that of the MIB in terms of content and scope as well as in terms of requirements. The board of examiners decides on the recognition.

In order to give students planning security, the creditability of selected courses and modules is determined in advance of the stay abroad by means of a Learning Agreement in individual counseling sessions with the chairperson of the board of examiners, the program coordinator, and in coordination with the individual subject representatives.

In addition to the specialization "European Studies", more than 250 partner universities of the KU as well as all universities worldwide are available as destinations for a *semester abroad*. The International Office supports students in their search for suitable programs for study or internship abroad as well as for appropriate financing options with information events and individual counseling services.

In preparation for the stay abroad, students can choose from a wide range of language courses offered by the KU Language Center. These language modules can be included in the study program as part of the elective area of the MIB with up to 10 ECTS credits.

2.3 Admission to the study program

The qualification for the Master's program in International Relations is proven by a first university degree with professional qualification in a course of study comprising at least six semesters of study in the fields of politics, society, economics, history or languages with an overall grade of at least 2.5 ("good") or law with an overall grade of at least "satisfactory".

Applicants must prove a good knowledge of German and English, both written and spoken (German at least level A2 of the European Framework of Reference, English at least B2): German language skills are proven either by the school leaving certificate, the first degree, a Goethe certificate (A2) or other qualifying proof. English language skills are proven either by the secondary school leaving certificate, the first degree, by successful participation in the TOEFL exam (with a minimum total score of 78) or another qualifying proof.

Candidates must also complete an aptitude testing procedure organized by the MIB board of examiners. The board of examiners appoints a selection committee for this purpose.

In the first stage of the aptitude test (pre-selection), the selection committee checks whether the applicants are "particularly suitable" for the course of study on the basis of their proven previous education on the basis of the documents submitted via the corresponding application platform of the KU. Particularly suitable applicants receive immediate admission. Candidates who meet the following criteria are considered particularly suitable:

- 1. Grade of 1.7 or better regarding the final grade of the entrance degree programme or in the preliminary average grade of the previous academic achievements, and
- 2. Major in Political Science, History, or Sociology in their first degree program; and

- 3. Stay abroad of at least one semester (four months) for the purpose of studies, internship or voluntary service.
- 4. Foreign applicants are also particularly suitable if they present a DAAD scholarship instead of the above criteria.

In addition, a personal interview is held with the candidates in order to check their professional and personal suitability in a standardized procedure. The personal interview, the date of which is set by the selection committee, has a duration of 20 to 25 minutes. The interview will take place by means of a video conferencing tool provided by the KU.

The interview is intended to provide information about the applicant's knowledge with regard to the relevant subject matter of the Master's program. Knowledge in the subject areas of international organizations (European Union, United Nations), political systems (forms of government, systems of government) and contemporary history (East-West conflict) will be tested.

The details of the suitability determination procedure are regulated in the annex to the examination regulations.

For the purpose of admission to studies, the Student Office decides on the comparability of the courses of study completed at foreign universities as well as on the equivalence of the university degrees obtained at foreign universities. It may consult the Central Office for Foreign Education in this regard.

3. Curriculum

3.1 Program structure and study contents

Students are basically free to organize their studies as they wish. However, the required and required elective areas of the curriculum define the modules to be completed in the interest of the qualification goals of the study program, which are supplemented and expanded in terms of content in the free elective area.

3.1.1 Required area

The required area focuses on the defined subject-specific and methodological foundations of a Master's program in International Relations from the Political Science sub-discipline of International Relations:

- The required module Theories, Structures and Orders in World Politics (10 ECTS)
 deepens historical and systematic knowledge on the theoretical and methodological
 foundations of the analysis of international relations as well as foreign policy research.
- The required module Policies, Strategies and Areas of International Relations (10 ECTS) deepens historical and systematic knowledge about politics (activities) and strategies of important global political actors and the areas of international politics constituted by them.
- Furthermore, a Master's module (5 ECTS) from the range of Studium.Pro offered by the KU must be completed. Studium.Pro offers students the opportunity to shape their educational and qualification path in an enriching way by means of a variety of interdisciplinary offers.

It is recommended to study the module *Theories, Structures and Orders in World Politics* in the first semester and *Policies, Strategies and Areas in International Relations* in the second semester respectively.

3.1.2 Internship

Students must complete a required internship of at least eight weeks; there is no maximum duration. The internship is recognized as a required internship if the degree program manager has approved the internship in writing before it begins (please see form "Internship Certificate").

The internship provides insights into a possible future professional field in the international and cross-border context and enables the acquisition of corresponding qualifications related to the professional field. Suitable internship institutions are international organizations, constitutional bodies and ministries at national level, administrative authorities, research institutions, media and non-governmental organizations.

Students of the specialization "European Studies" are recommended to complete the internship at an organization with European relevance (e.g. at European organizations such as the European Union or the Council of Europe, institutions close to them or other institutions from business and society with a European orientation).

Students are responsible for contacting suitable public or private institutions where the internship can be completed. German students should complete the internship abroad, foreign students in Germany. For internships abroad, students are supported by the International Office.

Students must submit a record of the internship period completed (see form "Internship Certificate") as well as a certificate issued by the internship institution stating that the internship has been properly completed (copy of the internship certificate). In addition, they must prepare

a fifteen-page internship report. If the report meets the requirements and the internship is evaluated as "passed", students will receive 15 ECTS credits for it.

3.1.3 Required elective area

The required elective area allows students to broaden and complement their focus of study with advanced courses in political science sub-disciplines (namely International Relations, Comparative Politics, and Political Theory and Philosophy), Contemporary History, International Law, and Sociology.

- The required elective module *Model United Nations* (10 ECTS credits) provides practice-oriented insights into the functioning of selected organs of the United Nations and simulation-based experience in formal and informal diplomatic negotiation. (offered in English language, in the winter semester)
- The required elective module *Constitutionalism* (10 ECTS credits) provides historical and systematic knowledge of the democratic constitutional state and its constituent principles, such as separation of powers, rule of law, right of opposition and constitutional jurisdiction. (offered in the summer semester)
- The required elective module *Comparative Political Science* (10 ECTS credits) teaches institutional as well as political-cultural basics of the political systems of selected political systems. Furthermore, methods, questions and theories of comparative political science are addressed. (offered in the winter semester)
- The required elective module *History of Political Thought* (10 ECTS credits) focuses on selected thinkers, currents or theoretical traditions from the different epochs of political thought. (offered in the summer semester)
- The required elective module Contemporary Political Theory and Philosophy (10 ECTS credits) analyzes contemporary political theories and philosophies, such as the theory of rational choice, complex theories of democracy and theories of justice. Furthermore, current theoretical debates are addressed. (offered in the winter semester)
- The required elective module Peace and Conflict Studies (10 ECTS credits) deepens
 the knowledge about different forms of political violence located on different levels of
 action as well as about possibilities to deal with them. ('container module' for the MIB;
 see 3.1.6)
- The required elective module International Political Economy (10 ECTS credits) provides a differentiated overview of central questions, analytical approaches and fields of application of International Political Economy (IPE) in relation to the disciplines of International Relations, Political Science and Economics. (offered in English language, in the winter or summer semester)
- The required elective module Contemporary History (10 ECTS credits) deepens the knowledge of historical events and developments from the 19th and 20th centuries. The focus can be on recent history and contemporary history about any region, on the history of Latin America, and on economic and social history. (offered partly in English language, in the winter and summer semester, recommended in the summer semester)
- The required elective module *International Law Sources, Principles, Current Developments* (10 ECTS credits) teaches the basic concepts of international law that are necessary for the study of International Relations. It deals with the basic principles and obligations of international law and discusses current developments in the international legal order. (offered in English language, in the winter semester)
- The required elective module Basic Modul Flight, Migration, Society (10 ECTS credits) teaches basic and in-depth knowledge in the subject areas of flight, migration and society. (offered in the winter semester)

- The required elective module *Criticism of Political Economy* (10 ECTS credits) offers a comparative analysis of sociological discourses on social structures and social processes and practices the discussion of relevant topics and the informed representation of one's own critical perspectives from a sociological perspective. (offered in the winter semester)
- The required elective module Advanced Sociological Theory (10 ECTS credits) addresses questions and problems of sociological theories and methods. Furthermore, sociological discourses are analyzed. (offered in English language, in the summer semester)
- The required elective module *Advanced Methods of Qualitative Analysis* (10 ECTS credits) deepens the knowledge of qualitative empirical research methods and the skills to apply them. It also addresses their integration into current sociological debates. (offered in the summer semester)
- The required elective module *Advanced Methods of Data Collection* (10 ECTS credits) deepens the knowledge of special methods of data collection and their application. (offered in the winter semester)

3.1.4 Elective area

The students should be able to get to know other subject areas beyond the knowledge imparted within the framework of the MIB and acquire key qualifications oriented towards practical and professional fields. In the elective area, students can therefore choose Master's modules from the entire range of subjects offered at the KU or modules from other German or foreign universities. Students are completely free to decide when they want to study which modules from the elective area. Students must provide evidence of achievements in the elective area amounting to a total of 10 ECTS credits. The examination achievements in the elective area are not taken into account in the formation of the overall grade.

3.1.5 Specialization "European Studies"

Since 2017, students have the possibility to complement their studies in the MIB with a specialization in "European Studies". This is offered in cooperation with the Department of European Studies at the Université de Fribourg/University of Fribourg in Switzerland.

Students of the MIB can complement their studies of International Relations with profound knowledge of European integration: History of the integration process, its legal, economic and cultural aspects are part of the range of contents of this structured stay abroad. In addition, students expand their knowledge of French, one of the working languages of the various European institutions.

Up to three students can usually spend the third semester of the MIB at our Swiss partner university. In turn, up to three students of the Master's in "European Studies" will spend one semester at the KU.

Completion of this structured stay abroad results in the following changes to the regular study structure and the distribution of ECTS credits:

In this case, the required area comprises 60 ECTS credits and students must successfully complete the following modules at the KU or the Université de Fribourg/University of Fribourg (UniFR):

- Theories, Structures and Orders in World Politics (10 ECTS credits) (1st semester, KU)
- Specialization European Studies 1: European Integration (15 ECTS credits) (3rd semester, UniFR)
- Specialization European Studies 2: Europe as Cultural Space (15 ECTS credits) (3rd semester, UniFR)

- Internship (15 ECTS credits)
- One Master's module (5 ECTS credits) from the Studium.Pro offer of the KU

From the elective area, the students have to bring in 30 ECTS credits.

Students must complete 10 ECTS credits from the elective area. Here, they can freely choose modules from the entire range of Master's degree programs at the KU that are not subject to admission restrictions or modules from other German or foreign universities. In particular, the offers of the Language Center of the KU can be used in the interest of further education in foreign languages.

Due to the deadlines, the structured semester abroad must be organized immediately after the start of studies in the MIB. Students who are interested in the specialization "European Studies" should apply to the degree program coordinator by December 15 of each year at the latest. In addition to a current résumé, they must also submit a short letter of motivation and proof of language proficiency (see below).

Although the Université de Fribourg/University of Fribourg is basically bilingual, knowledge of the French language is a central requirement for participation in the specialization "European Studies", if only because of the objective of the stay abroad. The language level should be at least B2 according to the European reference framework and is usually proven by the students by presenting the school leaving certificate or the first professional qualification. Language preparation for the stay within the framework of the offers of the Language Center of the KU is recommended.

The further organization of the stay is effected by the International Office or the responsible administrators at the Examinations Office. Their guidelines and deadlines apply. After successful completion of the studies in Fribourg/Freiburg, the Swiss grades will be recognized at the KU according to the following conversion table:

3.1.6 MIB in English

The degree program can also be completed in English. In addition to 3.1-3.4, the following instructions must be observed:

Required modules: For the modules Theories, Structures, and Orders and Policies, Strategies, and Areas of International Relations, the English-language course offering must be selected in each case. The same applies to Studium.Pro.

- Internship: Students usually complete the required internship in an English-speaking country. The internship report is written in English.
- Required electives: In particular, students take the English-language modules Model United Nations, International Political Economy and International Law as well as other English-language offerings of the Master's modules in Political Science, History (as a general rule offered in the summer semester) or Sociology.
- Furthermore, if applicable, English-language achievements from the study abroad can be credited to modules of the KU after prior consultation (see notes 2.2). The MIB 'container module' *Peace and Conflict Studies* is particularly suitable for this purpose. Alternatively, English-language courses from the Master's degree programme Conflict, Memory and Peace at the KU can also be credited in this module after prior consultation.
- Elective area: Students can choose English-language Master's modules from the entire range of subjects offered at the KU. In particular, language courses from the Language Center's offerings are recommended here, if applicable, in the interest of integration into university life as well as in preparation for studying abroad.

3.1.7 Master's thesis

The curricular program is usually completed by the Master's thesis. In it, students should prove that they have the ability to work independently according to scientific methods and to gain substantial results on a research topic. It can be written in German or English (after consultation with the supervisor of the thesis).

The topic of the Master's thesis can be assigned from the middle of the third semester at the earliest, if proof of required or required elective modules of the program amounting to at least 50 ECTS credits from the required and required elective areas is provided. Provided that these formal requirements are met, the thesis can be registered at any time.

The topic may be assigned from the fields of political science, history, and sociology. It must have clear international references.

The scope of the Master's thesis is determined in consultation with the supervisor and depends on the 20 ECTS credits to be awarded. Usually, the Master's thesis comprises approx. 50 pages of text. The processing time is four months.

A detailed "Master's Thesis Schedule" is available to students as a guide on the program's website.

3.2 Teaching and learning formats

The following forms of teaching and learning are offered in the modules of the Master's program in International Relations:

Lectures (VL). They address selected topics and issues of the subjects involved.

Exercises (UE). Under guidance, exercises deepen the knowledge acquired in the lectures they accompany.

Seminars (SE). They discuss objects and issues of the participating subjects at a higher level. They serve to deepen the studies and the ability to work independently in a scientific manner. Students give presentations and prepare term papers.

Colloquia (K). They discuss current trends in research. They also serve to discuss scientific papers.

Self-directed Learning (SGL). It accompanies the learning process in the courses to which it is assigned. Students independently deepen the knowledge acquired in the courses. It is accompanied by the lecturer through appropriate assignments.

Field Trips (EX). These are trips to selected institutions or regions. They are meaningfully related to the course to which they are assigned. They are prepared and followed up as part of this course. Students either give presentations on site, prepare reports of results, or perform other services accompanying the course.

3.3 Examination types

In the Master's program in International Relations, the following main examination types are used: examination interviews and presentations (oral forms of examination), written examinations, portfolios and assignments (written forms of examination).

Examination interviews last a minimum of 20 and a maximum of 30 minutes. As a rule, they relate to material presented in lectures. In examination interviews, students should demonstrate that they can present the examination material appropriately and solve problems appropriately.

Presentations are independently prepared lectures on a specific subject. They include an independent examination of a topic agreed upon with the lecturer, a presentation that is appropriate to the subject matter, the addressee, and the media, as well as adequate linguistic performance in the presentation and discussion. Presentations are usually supported by a written handout and suitable visual aids. The presentation should be followed by a technical discussion, which the lecturer leads or significantly accompanies. The duration of a presentation is 15 to 25 minutes for the presentation part and 10 to 20 minutes for the discussion.

Written examinations last 120 minutes. They usually relate to material presented in lectures. In the written examinations, students should demonstrate that they can present the interrelationships of the module in a limited amount of time and with limited aids and that they can recognize problems using the common methods of the subject and find ways to solve them. Multiple-choice examinations are permitted in compliance with Section 18 of the General Examination Regulations.

Written assignments are written elaborations on a set topic. They can be related to a presentation. In written assignments, students should prove that they can work on a topic independently. The length of a written assignment in a module with a value of 10 ECTS credits is 6500 to 7500 words, in a module with 5 ECTS credits 3600 to 4400 words. The term paper has to be handed in within nine or seven weeks respectively.

Portfolios are collections of coordinated achievements on a defined topic in the form of a workbook. Their length corresponds to a term paper depending on the ECTS points of the module. The deadlines also correspond to term papers.

Each module is examined with a module examination, whereby different examination types are used. The persons responsible for the module determine at the beginning of the lecture period which of the listed examination types in the module descriptions will be used. Only one examination type is offered per module and semester.

In practice, written assignments are the most common examination type in the MIB, as they serve in particular as preparation for writing the Master's thesis.

4. Study organization

4.1 Degree program manager and support services

The MIB is managed by the holder of the Chair of International Relations as the responsible program manager. According to Section 6 para. 3 General Examination Regulations (APO), the degree program manager is responsible for the description and coordination of the study program. He or she is supported by a degree program coordinator.

The degree program manager ensures that an up-to-date study program concept is always available, in which qualification goals, target group, content conception and implementation of the modularized study program are described and which is part of the study program description. In addition, the degree program manager ensures that an up-to-date ideal-typical program structure plan is always available. Furthermore, he or she supports the well-coordinated flow of all processes within the study program.

The degree program manager usually holds a planning meeting every semester. One of the purposes of this planning meeting is to coordinate the courses offered by the participating subjects for the following semester. In consultation with the persons responsible for the modules and the lecturers, the course coordinator then draws up a timetable for the required and required elective courses that contains as little overlaps as possible and makes this timetable available to the students for better orientation in their time planning.

4.2 Information, study support and advice

The degree program, the description of its contents and objectives are presented both on the Internet and in the form of information material. Up-to-date information on the degree program (such as the ideal-typical program structure, study requirements and module overview) as well as documents and forms are always available for download on the website of the degree program.

Every winter semester, an orientation and introductory event is held for newly enrolled students in the last week before the start of lectures or in the first week of the lecture period, in which the concept and goals of the Master's program, the structure and courses offered, the examination procedure, and the options for internships and stays abroad are presented and explained in detail.

The alumni concept "MIBPlus" strengthens the internal coherence of the degree program and offers both active students and alumni a forum for exchange of experiences, networking and individual continuing education. Targeted offers for graduates and students in the form of various networking services (e.g. newsletter, e-mailing list, annual meetings, lectures, etc.) are complemented by a targeted tutoring program "MIB Starter".

The degree program manager, the degree program coordinator, the subject representatives involved in the degree program, and the academic staff are available for study counseling during their office hours.

4.3 Quality assurance and control

The courses of the Master's Program in International Relations are evaluated by the students at regular intervals. The implementation of the evaluation is organized by the Faculty of History and Social Sciences. The results of the evaluations will be communicated to the teachers in an appropriate form and will be taken into account in the further implementation of the degree program.
