## Fee schedule for the Master of Business Administration (MBA) continuing education program at the Catholic University of Eichstätt-Ingolstadt

From September 23, 2021

amended by statute of 5 February 2025

Based on Article 5, Section 3, Sentence 1 of the Concordat between the Holy See and the Free State of Bavaria of 29 March 1924 (BayRS 2220-1-K) in conjunction with Article 71, Paragraph 2, Sentence 1 of the Bavarian University Act (BayHSchG), the Catholic University of Eichstätt-Ingolstadt issues the following fee schedule:

## § 1 Scope

This fee schedule applies to participation in the MBA master's program at the Catholic University of Eichstätt-Ingolstadt.

## § 2 Fee collection

- (1)<sub>1</sub>The fee for participation in the continuing education master's program is 17,600.00 euros for the standard period of study of four semesters, including the semester fees for four semesters. <sub>2</sub>Travel and accommodation costs for excursions to be completed as part of the MBA Master's program are not included in the fee and must be paid separately by the students.
- (2) The fee is payable by each student who enrolls or re-registers for the MBA Master's degree program at the Catholic University of Eichstätt-Ingolstadt.
- (3)₁The fee pursuant to paragraph 1 shall be paid in four instalments of EUR 4,400.00 each.₂The recipient of the payment is the Catholic University of Eichstätt-Ingolstadt.₃The first installment is due upon enrollment in the course of study.₄Payment is a prerequisite for enrollment.₅The second to fourth installments are to be paid upon re-registration for the second, third and fourth semesters.₅Re-registration is done by transferring the fee installment due for the coming semester.
- (4) If a student exceeds the standard period of study of four semesters, the respective semester fee must be paid for each additional semester in accordance with the Enrolment, Re-Registration and Exmatriculation Statutes of the Catholic University of Eichstätt-Ingolstadt (Enrolment Statutes).
- (5) If a semester of leave is granted in accordance with the enrollment regulations, the obligation to pay fees for the semester of leave is suspended. The semester fee must also be paid for the semester of leave.
- (6) If the Master's programme is interrupted or terminated without completion, there is no entitlement to reimbursement of fees already paid.
- (7) Payment of the fees does not release the student from other payment obligations towards the Catholic University of Eichstätt-Ingolstadt.
- (8) At the request of the student, payment of the fees to be paid in instalments may be agreed due to a special emergency situation of the student.

## § 3 Entry into force

This fee schedule comes into force on October 1, 2021.
